





Fig.1 Grounded Emitter Propagation Characteristics

Fig.2 Typical Output Characteristics




COLLECTOR TO EMITTER VOLTAGE : $\mathsf{V}_{\mathsf{CE}}\left[\mathsf{V}\right]$





Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current(I)






Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





Fig.8 Gain Bandwidth Product vs. Emitter Current

Fig.9 Emitter input capacitance vs. Emitter-Base Voltage Collector output capacitance vs. Collector-Base Voltage




Fig.10 Safe Operating Area




Fig.11 Safe Operating Area








Fig.12 Safe Operating Area




