



Fig.1 Ground Emitter Propagation Characteristics





Fig.2 Typical Output Characteristics

Fig.3 DC Current Gain vs. Collector Current (I)





Fig.4 DC Current Gain vs. Collector Current (II)

Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current (I)





Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current (II)

Fig.7 Base-Emitter Saturation Voltage vs. Collector Current





Fig.8 Gain Bandwidth Product vs. **Emitter Current**



COLLECTOR-BASE VOLTAGE: V_{CB} [V]


EMITTER-BASE VOLTAGE: V_{CB} [V]

SWITCHING TIME TEST CIRCUIT




