



Fig.1 Ground emitter propagation characteristics





Fig.2 Grounded emitter output characteristics

Fig.3 DC current gain vs. collector current (I)





Fig.4 DC current gain vs. collector current (II)

Fig.5 Collector-emitter saturation voltage vs. collector current (I)






Fig.6 Collector-emitter saturation voltage vs. collector current (II)




COLLECTOR CURRENT : I_C [A]

Fig.7 Base-emitter saturation voltage vs. collector current (I)





Fig.8 Collector output capacitance vs. collector-base voltage




COLLECTOR-BASE VOLTAGE: V_{CB} [V]

Fig.9 Emitter input capacitance vs.emitter-base voltage




EMITTER-BASE VOLTAGE: VEB [V]
