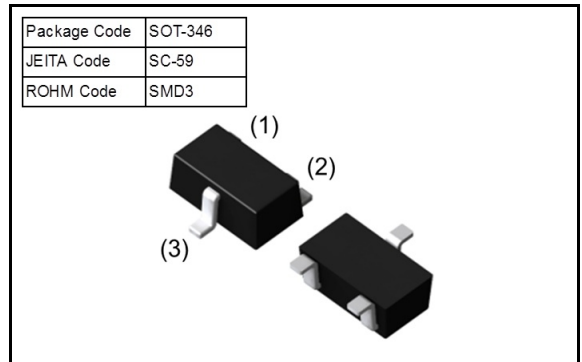

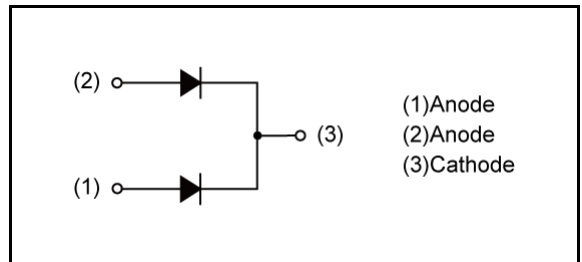

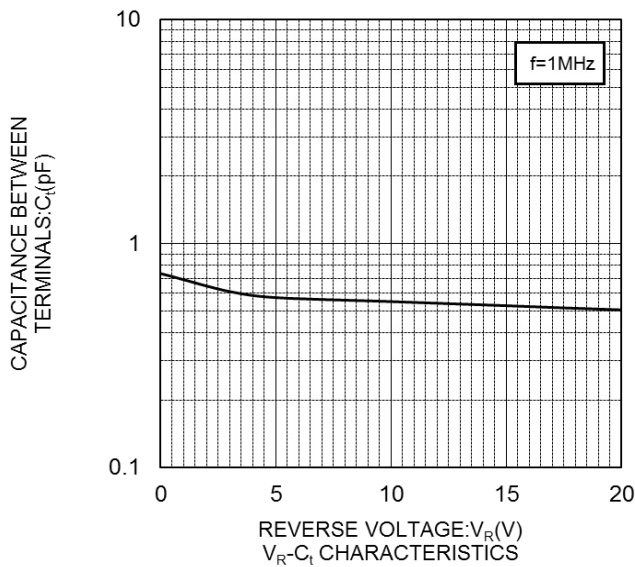
● Inner Circuit



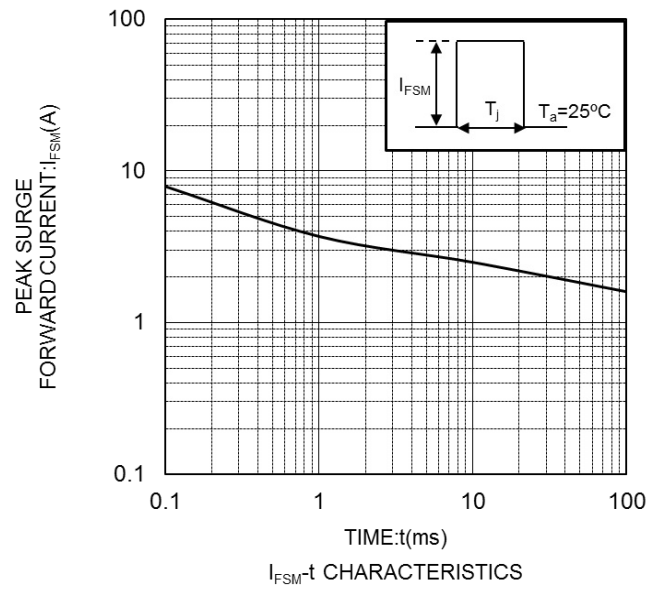
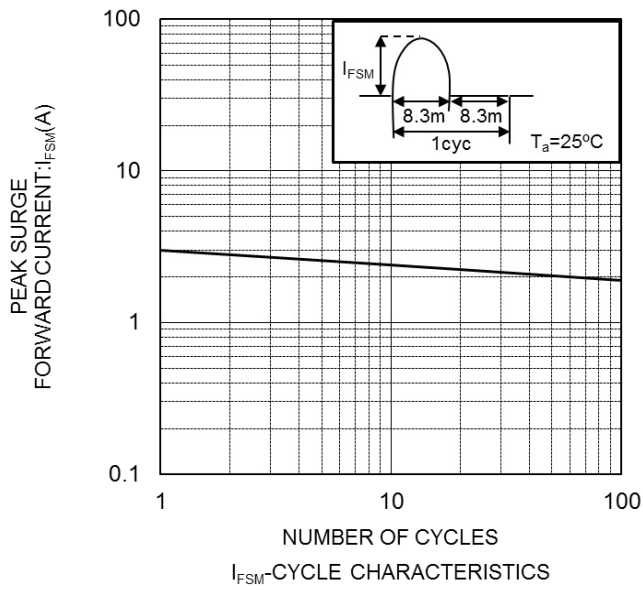
