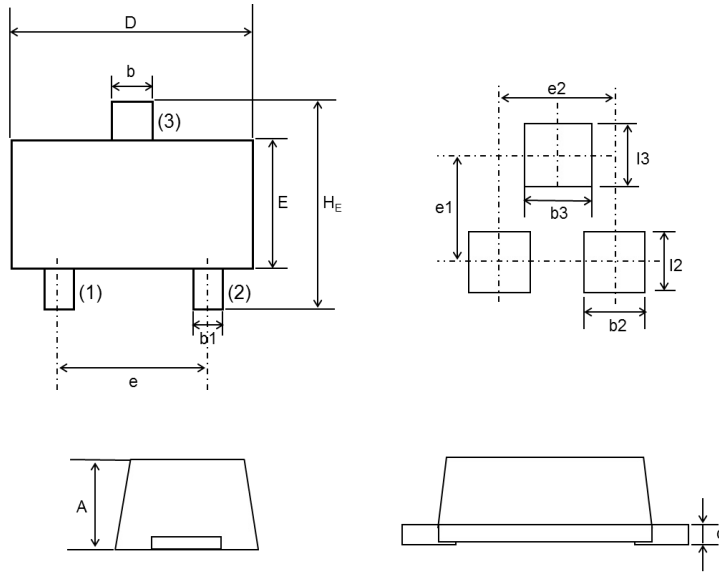
● Characteristic Curves



● Characteristic Curves

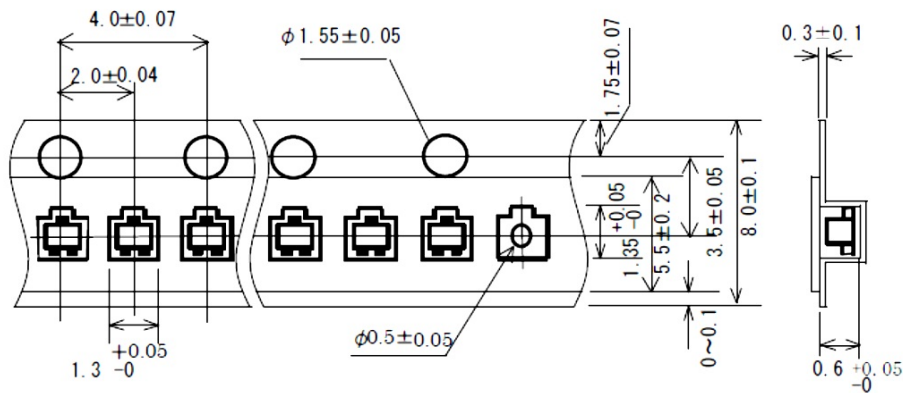
